1. Apologies for Absence

2. Minutes of Previous Meeting

The Minutes of the previous Group meeting, held on 18TH May, were unanimously approved.

3. Survey Questionnaire

The latest revision, draft 4CC, was tabled. This version incorporated amendments proposed by Members since the previous meeting and was also informed by reference to the Steeple Claydon NP survey questionnaire. With regard to the latter it was mentioned that there are numerous examples of NP survey questionnaires from other places to be found on the www by using 'neighbourhood plan survey questionnaire parish' or similar search terms.

It was suggested that questions, such as those concerned with obtaining details of recipients' houses, could be omitted in cases where the information requested was already available in the public domain. Nevertheless the meeting felt it would be easier to retain such questions in the questionnaire. Following further discussion it was proposed that IG, CC and DT meet, time permitting, prior to the next Group meeting for the purpose of refining the questionnaire. **Action: IG, CC, DT**.
